Petroleum Planning & Analysis Cell(PPAC) is a cell attached to Ministry of Petroleum and Natural Gas and its office is situated at Core-8, 2nd floor, SCOPE Complex, Lodhi Road, New Delhi-110 003. PPAC proposes to invite sealed quotation for procuring the following Insurance Policies for providing coverage to its employees and assets for the period **13.4.2019 to 12.4.2020.**

- **GPA Policy:** PPAC wants to provide insurance cover to their employees and the coverage insurance amount is as per grade of employees. A list of 37 PPAC employees is enclosed at Annexure-A-1. There may be a change in the list due to change in employee or grade which may or may not change the sum insured. PPAC will inform the insurance company to do such changes and proportionate premium will be paid /refunded accordingly.
- **Electronic Equipment Policy:** PPAC wants to provide Electronic Equipment Policy insurance cover (including earthquake, terrorism, RSMD, damage due to power surges) to its all office electronic equipment's at the value given at Annexure-A-2. The value of items to be insured are worked out based on their replacement value.
- **Fire and Burglary Policy:** PPAC wishes to procure Fire and Burglary Insurance Policy (including earthquake & terrorism) for its assets. Schedule with details attached at Annexure-A-3.
- **All risk cover (which includes earthquake & terrorism, RSMD, damage due to power surges)** for Laptops/Tablets hard disk and Projectors. We wish to procure all risk cover policy for Laptops/Tablets hard disk and Projectors as these are required to be carried from one location to another location for official purpose (including worldwide coverage). List of items to be insured with details is attached at Annexure-A-4.

The value of items to be insured (under Fire and Burglary Policy and All risk cover) are worked out based on their replacement value reduced by depreciation for the period of use up to 31.12.2018

CLAIM HISTORY: There has not been any claim on account of Insurance during the last 15 years under any insurance policy.
